

North/West Passage Project 9.1: Operations Task Force

2014-2015 Work Plan – September 24, 2014

Introduction

North/West Passage established a temporary Operations Task Force in 2013 that was intended to establish relationships, enhance the scope of operations-oriented projects, support further implementation of project findings, and increase interaction among the states outside of major events. The steering committee has extended the task force through August 2015 to allow them to further assess the value of an ongoing, dedicated group focused on traveler information and related operational coordination activities and projects.

The 2013-2014 work plan that was completed by the task force included updates to TMC/TOC operational contacts and information, discussions about major events and rural TMC/TOC operations, exchange of standard operating procedures and identification of an operations roadmap for the coming year. The task force has developed this 2014-2015 work plan to support the operations roadmap which is illustrated by the following points.

- Continue emphasis on **identifying, planning for and coordinating major events** – planned and unplanned.
- Continue **peer exchange style discussions of operational approaches** that individual states are using to manage events, particularly as it may support states developing TMC/TOC facilities.
- Monitor how **OTIS is supporting traveler information** in the corridor.

Participation

The task force participants provide more in-depth expertise on the states' individual operating procedures and on the approaches that North/West Passage could pursue to strengthen and maintain coordination among the states, particularly during major events. The states have confirmed the following participants to represent traveler information and Traffic Management Center (TMC)/Traffic Operations Center (TOC) operations issues on the task force.
